Dear DPac,

I am writing to follow up on yesterday's meeting regarding SOGI and the concerns some parents have

raised about sexually explicit material in the schools.

I would like to emphasize that it is the responsibility of the board to review and approve educational material, including books, not the Ministry of Education.

The government gave authority for education governance to locally elected school boards. School trustees are elected to local school boards to act for the legislature and for their local community. School trustees exist for the children, and their role is to guide, protect, defend, and advocate for them. Trustees partner with the parents as they provide the children with the best possible teachers and educational opportunities. The board is vicariously liable for the materials provided to children by teachers, principals, and school administrators. Parents expect the board to engage in the protection and supervision of minors in their care.

Schools have a duty of care to provide a safe and secure learning environment for students, and this includes protecting them from exposure to inappropriate material such as pornography or other explicit content. The policy and law are in place to ensure that children are not subjected to harmful or offensive materials within the school setting. If any teachers or board members are found to be promoting or distributing inappropriate material to students, immediate action should be taken to address the issue, and the removal of the inappropriate material should be immediate. Disciplinary measures should also be taken, such as termination of employment, suspension of certificate, or legal action if necessary. It is the responsibility of trustees and other school officials to ensure that all staff members are aware of the policies and laws regarding inappropriate material in schools and that they are held accountable for any violations. By taking swift and decisive action, trustees can help to ensure that children are protected from harm and that schools maintain a safe and healthy learning environment for our children.

"Boards of education have responsibility for determining how learning resources are chosen for use in schools. Boards must have policies and procedures for choosing learning resources. For curricula implemented from 2016 onwards, most educational program guides will not include a list of Ministry recommended resources. Boards may continue to use learning resources specified in educational program guides published before 2016, as appropriate. For certain courses or grades, the Ministry may still recommend the use of specific learning resources from time to time."

"The Ministry of Education and Child Care no longer conducts evaluation processes to recommend learning resources. This responsibility now rests with boards. Board policies and procedures should include a process for ensuring the list of recommended learning resources is up to date and aligned with changes in curriculum. This would include adding and removing resources from the list."

"Any concerns or challenges to the use of a learning resource should be dealt with at the district level. Boards/authorities should also develop policy and procedures to challenge the use of a learning resource." https://www.bclaws.gov.bc.ca/civix/document/id/complete/statreg/96412_06

"SCHOOL ACT [RSBC 1996] CHAPTER 412 Provision of educational program Section 75 (7)Subject to the regulations, a board (a)is responsible for evaluating all of the educational programs and services provided by the board, including services provided under an agreement under section 86 (1) (a), and"
